I hereby represent and warrant that the undersigned has full power and authority to execute this Agreement and to grant the rights herein granted, and that no other consents, authorizations or payments are necessary to permit the full use and enjoyment by Producer of the rights granted herein; and that use of said Materials, or any part thereof, in accordance with the terms and conditions of this Agreement will not violate or infringe upon the trademark, trade name, service mark, copyright, patent, artistic, personal, private, civil or property right, right of privacy, right of publicity, or any other right of any person or entity, nor constitute a libel or slander of any person, and that the undersigned shall indemnify, save and hold harmless Producer from and against all claims, actions, losses, damages, judgments, liabilities, expenses and costs (including reasonable outside attorneys' fees and costs) resulting from any breach or alleged breach of the foregoing representations and warranties. In no event shall I have any right to seek or obtain injunctive or other equitable relief in connection with the Picture or any other Producer production, or the production, distribution, exhibition or other exploitation, or the advertising, promoting or publicizing thereof. This is the entire Agreement and, subsequent to execution, cannot be modified without written consent by both parties. This Agreement shall be exclusively governed by and construed in accordance with the laws of the State of Florida, and Orange County, Florida shall be the venue for any action, state or federal. Producer shall have the right to transfer and assign its rights and/or obligations pursuant to this Agreement to any other person, corporation or entity in its sole discretion. The provisions of this Agreement shall be binding upon the parties and their respective heirs, executors, administrators and successors.
